Funding Status

In 2022, 506 religious communities provided data to the National Religious Retirement Office (NRRO) regarding their assets available for retirement. From this information, the NRRO calculated the extent to which a community is adequately funded for retirement. Shown below are the number of religious institutes at each level of funding and the total number of women and men religious represented by these institutes.

Dear Friends,

I am pleased to report that, thanks to the generosity of concerned Catholics nationwide, the collection for the Retirement Fund for Religious raised \$27.6 million for 2022.

This year's supplement to the annual report of the National Religious Retirement Office (NRRO) includes a comprehensive list of the 297 religious communities that received funding because of your generous contributions. Organized by state, the list provides detailed information about how your donations directly impact religious communities across the country.



Many religious communities still struggle with insufficient retirement savings. Despite our ongoing efforts to provide support and resources, the need remains great. Among the congregations who have shared data with our office, the majority are facing a significant financial deficit in meeting their retirement requirements.

The NRRO's Management Committee has decided to distribute \$25 million in financial assistance for the direct care of elderly religious. This funding will help provide critical care and support for our aging religious sisters and brothers.

While we are proud of the progress made in addressing retirement-funding shortages for religious communities, much work remains to be done. Your continued support greatly helps us provide the necessary resources to care for aging members.

Fund Distributions

Direct Care Assistance

The 2022 collection for the Retirement Fund for Religious enabled the National Religious Retirement Office (NRRO) to distribute Direct Care Assistance to 297 religious institutes. These funds support the immediate care of elder religious and help religious institutes bolster retirement savings. Direct Care Assistance is an annual, per capita distribution based on specified criteria, including the level of need. Funds are sent to each eligible institute's central house.

Planning and Implementation Assistance

The Planning and Implementation Assistance program, which offers consultative and financial support to help struggling religious communities meet retirement expenses, has reached a milestone. Since 2009, approximately 150 congregations have successfully addressed their funding deficits through the program.

Given the evolving landscape, the number of religious communities able to meet the program's participation criteria has decreased. In 2022, the remaining institutes below received funding to complete the process through the Planning and Implementation Assistance program.
