In 2023, 476 religious communities provided data to the National Religious Retirement Office (NRRO) regarding their assets available for retirement. From this information, the NRRO calculated the extent to which a community is adequately funded for retirement. Below are the number of religious institutes at each level of funding and the total number of women and men religious represented by these institutes.

Direct Care Assistance

The 2023 collection for the Retirement Fund for Religious enabled the National Religious Retirement Office (NRRO) to distribute Direct Care Assistance to 286 religious institutes. These funds support the immediate care of elderly religious and help religious institutes bolster retirement savings. Direct Care Assistance is an annual, per capita distribution based on specified criteria, including the level of need. Funds are sent to each eligible institute's central house.
